Comments of INVESCO ^ 景順基金經理評論

Recession fears and unprecedented risk aversion undermined global equities during the fourth quarter of 2008. Most of the weakness in stock prices was concentrated in October when the banking crisis in the US and Europe, following the earlier collapse of Lehman Brothers, prompted a wave of selling by distressed hedge funds. Although stock prices staged a small recovery towards the end of the year, aided by the announcement of fiscal stimulus packages from several governments, the MSCI World IT (US\$) index still recorded a quarterly decline of 24.5%. Over the longer term, we continue to see positive trends in the IT sector as we believe it is supported by three key themes that are secular in nature and not dependent on a short-term catalyst. These themes are globalisation, consumerisation and proliferation. With the first, productivity gains are supporting increased use of technology in international markets. With the second, demand for technology is being driven by the consumer, regardless of age or gender. With the final theme, technology continues to penetrate products for all types, ranging from cars and industrial controls, to sports equipment and alternative energy.

市場憂慮環球經濟衰退，加上投資者的避險意欲達致前所未見的水平，削弱環球股市在2008年末季的表現。股價錄得的跌幅大部分發生在10月份。雷曼兄弟宣告破產，導致美國及歐洲爆發銀行業危機，觸發受壓的對沖基金大舉沽售資產，以套現進行補倉。儘管接近年終，因多國政府宣佈刺激經濟的財務政策，股價出現輕微回升，但摩根士丹利世界資訊科技(美元)指數仍錄得24.5%的季度跌幅。長遠而言，我們繼續看好資訊科技股的走勢，因為獲三項重要的長期主題所支持，這些主題不受短期的因素影響，包括全球化、消費者化及迅速擴展。全球化方面，生產力上升支持國際市場增加科技的應用。消費者化方面，不論年齡或性別，消費者均帶動對科技的需求。迅速擴展方面，科技的應用已擴散至各類型的產品，由汽車及工業控制設備以至體育用品及另類能源。

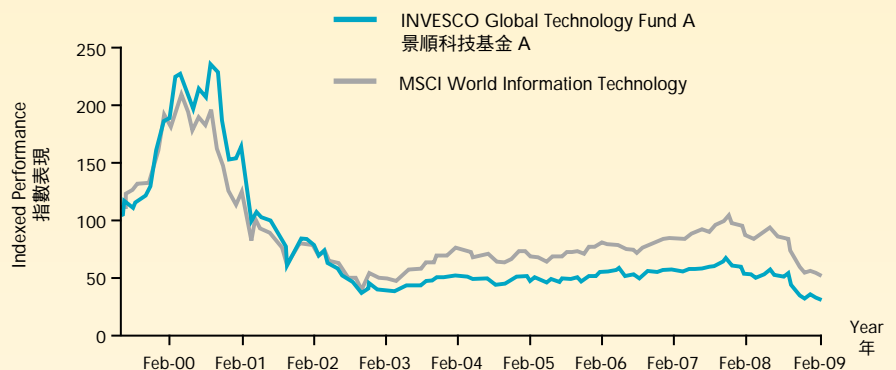

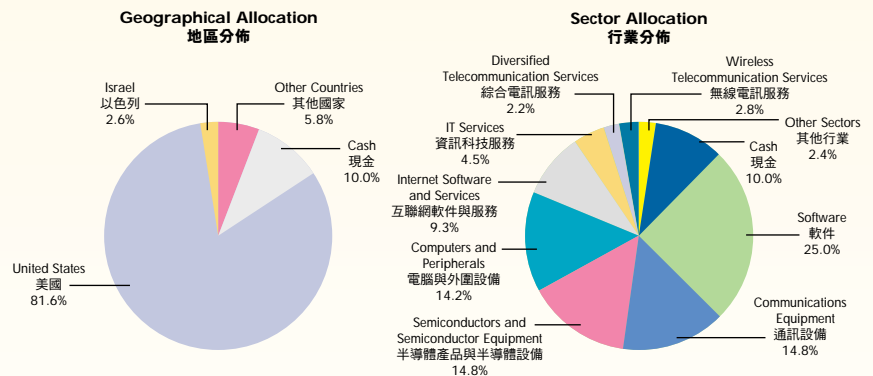
